Complementizers in Modern Irish

(1) Movement-related morphology in Modern Irish:

- a. Creidim gu-r inis sé bréag
I-believe C:go-PAST tell he lie
'I believe that he told a lie.'
- b. Céacu ceann₁ a dhíol tú t₁ ?
which one C:aL sold you
'Which one did you sell?'
- c. an t-ainm OP₁ a hinseadh dúinn a bhí t₁ ar an áit
the name C:aL was told to us C:aL was on the place
'the name that we were told was on the place'
- d. Céacu ceann a bhfuil dúil agat ann ?
which one C:aN is liking at you in it
'Which one do you like?'

Complementizers in Modern Irish

(1) Movement-related morphology in Modern Irish:

- a. Creidim gu-r inis sé bréag
I-believe C:go-PAST tell he lie
'I believe that he told a lie.'
- b. Céacu ceann₁ a dhíol tú t₁ ?
which one C:aL sold you
'Which one did you sell?'
- c. an t-ainm OP₁ a hinseadh dúinn a bhí t₁ ar an áit
the name C:aL was told to us C:aL was on the place
'the name that we were told was on the place'
- d. Céacu ceann a bhfuil dúil agat ann ?
which one C:aN is liking at you in it
'Which one do you like?'

Analysis in McCloskey (2002, 203):

- (i) C which bears both the Op-feature and the EPP-feature is realized as aL.
- (ii) C which bears only the EPP-feature is realized as aN.
- (iii) C which bears neither the Op-feature nor the EPP-feature is realized as go.

Little v in Malay

(2) Movement-related morphology in Malay:

- a. Ali mem-beritahu kamu tadi [Fatimah mem-baca apa₁] ?
Ali meN-told you just Fatimah meN-read what
- b. Apa₁ (yang) Ali (*mem)-beritahu kamu tadi [(yang) Fatimah
what that Ali (meN)-told you just that Fatimah
(*mem)-baca t₁] ?
meN-read
- c. Ali (mem)-beritahu kamu tadi [apa₁ (yang) Fatimah (*mem)-baca
Ali (meN)-told you just what that Fatimah meN-read
t₁] ?

Complementizers in Kinande

- (3) **Movement-related morphology in Kinande (Bantu)** (wh-agreement):
- a. [CP Ekihi₁ [C kyo] Kambale alangira t₁] ?
what that Kambale saw
'What did Kambale see?'
- b. [CP Iyondi₁ [C yo] Kambale alangira t₁] ?
who that Kambale saw
'Who did Kambale see?'
- c. [CP Ekihi₁ [C kyo] Marya alengekanaya [CP t₁ nga-kyo Kambale
what that Mary thinks C-that Kambale
asoma t₁]] ?
read
'What does Mary think that Kambale read?'

Subject Pronouns in Ewe

(4) Movement-related morphology in Ewe:

- a. Kofi₁ e me gble na t₁ [CP be é/*wo fo Kosi]
Kofi FOC I said to that he hit Kosi
'It was Kofi that I told that he hit Kosi.'
- b. Kofi₁ e me gble [CP t'₁ be é/wo fo t₁]
Kofi FOC I said that he hit
'It was Kofi that I said that he hit.'
