Overview

In this seminar, we will be concerned with the syntactic properties and the morphological realization of the grammatical category *passive*. We will look at different theoretical approaches that have been suggested over the years, and we will consider data from a variety of typologically distinct languages. Important theoretical questions that will be addressed include the distinction between inflection and word formation and the modelling of the morphology/syntax interface.

Goal:

Based on the material discussed in this course, participants develop analyses of (aspects of) passive constructions (that are, or can be shown to be, not that well understood yet) in a language of their choice; the analyses will be presented in short presentations at the end of the semester.
